Call to Order

- Ken Kunsman called the Kylemont HOA BOD meeting to order at 7:02 PM
- The minutes from the September 11, 2023 Kylemont HOA BOD meeting were approved.

Treasurer's Report

- HOA accountant Rob Moore reviewed 2023 HOA expenditures versus the 2023 HOA budget. Year to date, expenditures are in line with the budget.
- The following new insurance policies from Harris / Auto-Owners / Southern-Owners were purchased:
 - ➤ HOA Surety Insurance Annual premium of \$294 for \$100k coverage (versus \$126 for \$10k)
 - ➤ Commercial and Umbrella Liability Insurance Annual premium of \$1,616 & \$610 (versus \$4,281)
- The BOD approved the Treasurers Report.
- The BOD reviewed and approved a 2024 HOA budget with an annual fee increase of \$50 to cover the LMA fee increase. The 2024 HOA annual fee will be \$1,725 with \$100 discount for single full payment.

 the lack of appropriate landscaping in front of their home

Old Business

- The homeowners of 3858 Keystone Way have not responded to the request for documentation on keeping emotional support chickens on their property
- Nov. 4 Garage Sale Report It was reported that 16 homeowners participated.
- Garbage / Recycle Collection A 3-yr contract was executed with Coastal Waste and Recycling for a flat fee of \$1,800 per month (~\$350 per month reduction of previous billing)
- Notice of the Dec. 11 Annual Meeting & BOD election ballots were mailed to homeowners in early Nov.

New Business

- A West Coast \$1,395 quote for enhancement of the Knob View Way entrance was tabled until the spring of 2024
- The BOD agreed to review a proposal for a 500 feet extension of the drip line along the High Point berm
- Homeowner volunteers will decorate the Kylemont entrance on Sat., Nov. 25
- The East Lake Fire Santa is scheduled to visit Kylemont on Thursday, Dec. 7
