- LMA Fining Committee Development status undetermined
- Ground water system 5-year inspection Zoller Engineering completed their inspection, and a report will be filed with SWFWMD by the May deadline. Zoller Engineering indicates that there are no issues to report.

- HOA Governing Documents and the Marketable Record Title Act The BOD approved a motion to file notices for preserving the HOA governing documents from extinguishment under the Marketable Record Title Act.
- New Florida law requirements for HOA Board member certification The BOD approved an expenditure for up to \$200 for online HOA BOD member certification courses as required by Florida State Statute

Tyler McKinney expressed concern on the condition of the landscaping on the High Point berm behind his home. Jane
Swango indicated that she has noticed an issue with the irrigation drip line and has contacted the LMA President and
landscape maintenance personnel. It was noted that once the irrigation issue is resolved, installing additional plantings
will be reviewed.
